INTRODUCTION

This joint field meeting will be an opportunity for cavers, cave scientists, geologists, mine history specialists, quaternary scientists and local residents to gather and share knowledge and enthusiasm for this special but relatively little-visited location. There are several fine cave systems in the North Pennines but the region is most notable for hosting the longest and most complex maze caves in Britain. In contrast to the majority of British caves which are epigenic (formed by descending waters) the maze caves are of hypogenic origin, that is they were formed by rising waters. As such they have no connection to the present land surface and are only accessible because they were intersected by lead miners.

The North Pennines UNESCO Global Geopark has first class interpretation of Geo Heritage and Geo Conservation at local visitor centres and on line resources that can be found at <http://www.northpennines.org.uk/about-us/unesco-global-geopark/>. Study of this facility is highly recommended.

The meeting will comprise a series of talks and four categories of field visit:

- surface geological site visits led by some of the regions most experienced geologists.
- self-guided walks.
- guided visits to some of the best introductory caves this region has to offer (these will be suitable for persons who have a reasonable degree of physical fitness but have little or no experience of cave exploration).
- guided visits to more extensive caves (suitable for those who have previous caving experience).

PROGRAMME

Saturday 29th - 9.30am & Sunday 30th - 9.00am

On both days there will be a short morning session of introductory lectures in the Village Hall followed by a selection of surface geological/ heritage walks or underground visits. These will include caves suitable for novices and more serious caving venues. The following caves have permits in place for both days.

EQUIPMENT / HEALTH & SAFETY

Full Waterproof body cover and walking boots are recommended for all guided and self-guided walks. The weather in the North Pennines in June can still be poor so please prepare appropriately for such an eventuality.

The underground activities will require standard caving PPE and helmets/caving lights.

Novices will be provided with a helmet and light but will need fleece base layer and mid layer plus old waterproofs to wear underground. Wellington boots are ideal footwear.
